(2) That on 2/22, 2000 the owner owed the following described land in the County of Cook, State of Illinois, commonly known as: 6555 S. UNIVERSITY, Chicago, IL, and TIM ROBINSON was the owner's contractor for the improvement thereof.

(3) That on 2/27, 2000 said contractor made an oral subcontract with the claimant to furnished material disposal receptacle(s) and material disposal services for and in said improvement, and that on 2/27, 2000, the claimant completed thereunder all required by said oral contract to be done, delivery and pick-up of material disposal receptacle(s) and the transportation thereof said material to a disposal gibe to the value of FOUR HUNDRED THIRTY (\$ 430 .00) Dollars.

(4) That said owner, or agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) does not reside in said County.

(5) That said contractor is entitled to credits on account thereof as follows, to-wit:

None leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of FOUR HUNDRED THIRTY (\$ 430 .00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other consideration due or to become due from the owner under said contract against said contractor and owner.

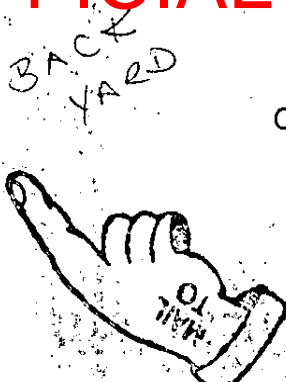

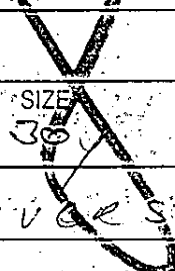
