



DISCHARGE OF MORTGAGE



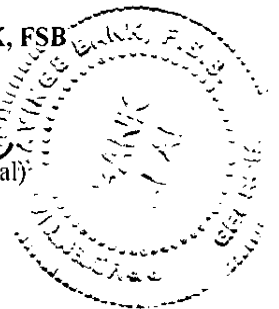


