ILLINOIS STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPER



POWER OF ATTORNEY, made this 20TH day of February, 2001.

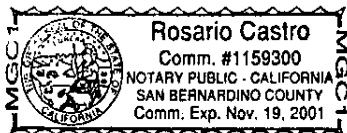
