LOAN MODIFICATION AGREEMENT

THIS AGREEMENT, is made and entered into as of March 28, 2001, but made effective as of April 3, 2001, by and between MID TOWN BANK AND TRUST COMPANY OF CHICAGO, an Illinois corporation ("BANK"). PAUL F. LOAIZA ("BORROWER") and .MID TOWN BANK AND TRUST COMPANY OF CHICAGO, NOT PERSONALLY BUT AS TRUSTEE UNDER TRUST AGREEMENT DATED MARCH 14, 1997 A/K/A TRUST NO. 2111 ("MORTGAGOR").

WHEREAS:

- 1. The BORROWER has heretofore executed a Promissory Note dated **April 7, 1997** in the principal amount of \$152,000.00 of which the BANK is presently the colder;
- 2. The NOTE is secured by a Mortgage, Assignment of Reris & Security Agreement (Chattel Mortgage) dated April 7, 1997 and recorded in the Recorder's Office of Cool: County, Illinois, as document number 97924433 ("MORTGAGE"), conveying to BANK certain real estate described in Exhibit "A" attached hereto and by this reference incorporated herein ("REAL ESTATE");
- 3. The NOTE is further secured by a Collateral Assignment of the Beneficial Interest in that certain Land Trust which is known as Mid Town Bank and Trust Company of Chicago 1/t/u Trust Agreement dated 3/14/97 a/k/a Trust No. 2111 ("ASSIGNMENT OF BENEFICIAL INTEREST") which land trust holds title to the described REAL ESTATE;
- 4. The BANK has disbursed to BORROWER the sum of \$152,000.00 which amount represents the entire principal sum of the indebtedness evidenced by the NOTE, of which there is an outstanding balance of \$143,624.32;
- 5. The interest rate evidenced on said NOTE is 8.25% per annum;
- 6. The maturity date evidenced on said NOTE is May 1, 2002;
- 7. The BORROWER desires to amend the loan amount, interest rate, repayment terms and maturity date as evidenced by the NOTE;
- 8. The BANK has agreed to such modification pursuant to the terms and conditions of a commitment of the BANK dated **March 28, 2001** ("COMMITMENT").

NOW THEREFORE, notwithstanding anything contained to the contrary in the NOTE and MORTGAGE, and in consideration of the mutual covenants, conditions, and premises contained herein, the PARTIES HERETO AGREE AS FOLLOWS:

- A. The principal amount evidenced by the NOTE as of this date is \$209,000.00.
- B. The interest rate evidenced by the NOTE as of the effective date is 7.895% per annum.
- C. Principal and interest payments in the amount of \$1,598.59 (based on a 25 year amortization) shall be due and payable monthly beginning May 3, 2001, and on that day each month thereafter until all of said outstanding principal plus any remaining accrued interest and late charges, if any, are repaid in full.
- D. The maturity date is hereby amended to April 3, 2006.
- E. In the event of propovement of the principal before maturity, Lender will be entitled to additional funds to maintain the expected yield of the mortgage over the anticipated term of the mortgage (see Yield Maintenance Program Rider attached hereto and made a part hereof).
- F. Except as modified herein, the terms, covenants and conditions of the MORTGAGE shall remain unchanged and otherwise in full force and effect. In the event of any inconsistency between the terms of this agreement and the terms of the NOTE and/or MORTGAGE, the terms herein shall control.
- G. The lien of the MORTGAGE is hereby modified as security for the payment of the principal sum evidenced by the NOTE and amended by this MODIFICATION AGREEMENT.
- H. This agreement shall be governed by and construed under the laws of the State of Illinois.

This instrument is executed by Mid Town Bank and Trust Company of Chicago not personally but solely as trustee, as aforesaid. All the covenants and conditions to be performed because by Mid Town Bank and Trust Company of Chicago are undertaken by it solely as Trustee, as aforesaid and not individually, and no personal liability shall be asserted or be enforceable against Mid Town Bank and Trust Company of Chicago by reason of any of the covenants, statements, representations or warranties contained in this instrument.
