#### MEMORANDUM OF LEASE

- This Memorandum is executed and reco ded solely for the purpose of giving record notice of 4. the existence of the Lease. This Memorand in creates no rights or obligations and does not constitute a part of the Lease, nor shall this Meriorandum be used to interpret the Lease. The rights and obligations of Landlord and Tenant shall be construed solely by reference to the provisions of the Lease and in the event of any conflict between the provisions of the Lease and those of this Memorandum, the provisions of the Lease shall control. 3/4's Office
