



TRUSTEE'S DEED

THIS INDENTURE, made this 30th day of March, 2001, between **LASALLE BANK NATIONAL ASSOCIATION** (as successor trustee to American National Bank And Trust Company Of Chicago), a corporation duly organized and existing as a national banking association under the laws of the United States of America, and duly authorized to accept and execute trusts within the State of Illinois, not personally but as Trustee under the provisions of a deed or deeds in trust duly recorded and delivered to said national banking association in pursuance of a certain Trust Agreement, dated the 16th day of December, 1985, as amended and restated on April 18, 1991, and known as Trust Number **66307**, party of the first part, and **RICHARD B. This deed is executed by the party of the first part, as Trustee, as aforesaid, pursuant to and in the exercise of the power and authority granted to and vested in it by the terms of said Deed or Deeds in Trust and the provisions of said Trust Agreement above mentioned, and of every other power and authority thereunto enabling. This deed is made subject to the liens of all trust deeds and/or mortgages upon said real estate, if any, recorded or registered in said county.
