Purpose of Modification:

TO MODIFY ORIGINAL MORTGAGE TO PROVIDE AN ADDITIONAL ADVANCE OF FUNDS IN THE AMOUNT OF \$100,000.00; TO MODIFY THE PRINCIPAL AND INTEREST PAYMENT FROM \$1806.05 TO \$2520.34.

This Second Loan Modification Agreement (hereinator referred to as "Modification") made and entered into this $_{22\mathrm{ND}}$ day of $_{\mathrm{FEBRUARY}}$, $_{2001}$ by and between Mid America Bank, fsb. of the County of DuPage and State of Illinois (FKA MidAmerica Federal Szvings Bank, and hereinafter referred to as ("MidAmerica") and $_{\mathrm{GRZEGORZ}}$ CZERNECKI AND TERESA CZERNECKI. HUSBAND AND WIFE

(hereinafter referred to collectively as "Borrowers") shall affect the property located at 4928 N MONITOR CHICAGO, IL 60630

LOT 515 AND THE SOUTH HALF (1/2) OF LOT 516 IN WILLIAM ZELOSKY & COLONIAL GARDENS, A SUBDIVISION OF THE WEST FRACTIONAL HALF (1/2) OF THE SOUTHEAST FRACTIONAL QUARTER (1/4) OF FRACTIONAL SECTION EIGHT (8), TOWNSHIP FORTY (40) NORTH, RANCE THIRTEEN (13), EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

WHEREAS, a loan modification was previously entered into by and between MidAmerica and Borrowers evidenced by a Loan Modification Agreement dated December 11, 1998 (hereinafter referred to as "First Modification");

WHEREAS, the parties hereto for mutual consideration wish to revise the terms of the Note, Mortgage and First Modification of said indebtedness:

NOW THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

It is agreed that as of the date of this Modification, the unpaid principal balance of said indebtedness is One Hundred Forty-three Thousand Three Hundred Thirteen and 78/100ths Dollars (\$143,313.78).

The Note and Mortgage dated May 30, 1997 shall be modified to provide for an additional advance of funds not to exceed the amount of One Hundred Thousand and 00/100ths Dollars (\$100,000.00).

Mid America will fund an Additional Advance of One Hundred Thousand and 00/100ths Dollars (\$1,00,000,00) which shall increase the unpaid principal balance of said indebtedness to Two Hundred Forty-three Thousand Three Hundred Thirteen and 78/100th Dollars (\$243,313.78).

The Borrowers do hereby amend and modify the Note and Mortgage described above by specifically amending Section 2 (Interest) and Section 3 (Payments) of the Note as follows:

As of February 1, 2001, the modified interest rale the Borrowers are required to pay will be 6.500%.

This modified interest rate will remain constant for the remaining term of the loan. The principal and interest payment based on the rate indicated above will be \$2520.34. The Borrowers shall make the new modified payments on the first day of each month beginning on March 1, 2001.

It is agreed that all sums owed under the Note will be paid note: than July 1, 2012 ("the Maturity Date") and the Maturity Date under all the Loan Documents will be deemed July 1, 2012. To the extent the terms, conditions and provisions of this Modification differ from or are inconsistent with the Note, Mortgage or other Loan Documents executed by the Borrowers, the terms, conditions and provisions of this Modification Cort's Orice shall control and govern.
