Common Element appurtenant to the Grantee's Parcel, an Exclusive Parking Use for parking purposes in and to Parking Space No. 2-W-20 as defined and set forth in the Declaration and in the Survey attached hereto.
- The rights and interests herein granted and created shall be subject to the provisions of the Declaration and 2. shall run with the land and shall inure to the benefit of and be binding upon all present and future owners, purchasers, mortgages, tenants, occupants and any persons acquiring any interest in the Grantee's Parcel. 
