This Partial Assignment and Assumption of Ground Lease and Special Warranty Deed (this "Agreement") is made as of this 16^h day of March, 2001, by and between RKZ VENTURE GROUP, L.L.C., an Illinois limited liability company, whose address is 8410 West Bryn Mawr Avenue, Chicago, Illinois 60631 ("Assignor/Grantor"), and BARBARA J. KUCERA, as Trustee of Barbara J. Kucera Revocable Trust dated August 1, 1989, whose address is 111 E. Chestnut, #44P, Chicago, Illinois 60611 (Assignee/Grantee").

Assignor/Grantor, for and in consideration of the sum of Ten and No/Dollars (\$10.00) and other good and valuable consideration in hand paid by Assignee/Grantee, the receipt of which is hereby acknowledged, by these presents



does REMISE, RELEASE, ALIEN AND CONVEY, AND ASSIGN, unto Assignee/Grantee, the Property, situated in the County of Cook and State of Illinois known and described as Exhibit "A" attached hereto and made a part hereof (collectively, the "Property").

Together with the exclusive right to use and enjoy the Limited Common Area appurtenant to the Building Site and legally described on Exhibit "B" attached hereto and by this reference made a part hereof (the "Limited Common Area"), in accordance with the provisions of the Declaration. Together with all and singular hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion or reversions, remainder or remainders, rents, issues and profits thereor, and all the estate, right, title, interest, claim or demand whatsoever, of Assignor/Grantor, either in law or equity of, in and to the Property, with the hereditamen's and appurtenances (but excluding fee simple title to the land):

TO HAVE AND TO HOLD, the Property, with the appurtenances, unto Assignee/Grantee.

And Assignor/Grantor, for itself and its successors, does covenant, promise and agree to and with Assignor/Grantee and its successors, that it has not done or suffered to be done, anything whereby the Property is, or may be, in any manner encumbered or charged, except as recited in this Agreement; and that it WILL WARRANT AND DEFEND the Property against all persons lawfully claiming or to claim the same, by, through or under it, subject only to:

(1) general real estate taxes not due and payable at the time of closing: (2) the Ground Lease, including those amendments and exhibits of record as of the date hereof, and new amendments or exhibits recorded in compliance with Section 5 hereof, amended; (3) the Declaration, including only those amendments or exhibits of record as of the date hereof, unless same are otherwise approved by Purchaser in writing (with the exception of an amendment to include Phase III, which shall be substantially similar to the amendment to include Phase II; (4) applicable zoning and building laws and other ordinances of record provided that same do not under le the Residence and will not interfere with Purchaser's intended use of, access to. or occupancy of, the Property; (5) acts done or suffered by Purchaser or anyone claiming by, through or under Purchaser; (6) utility easements, i any, whether recorded or unrecorded, provided the same do not underlie the Residence and will not interfere with Purchaser's intended use of, access to. or occupancy of, the Property; and; (7) covenants, conditions restrictions, easements, declarations and agreements of record, including, without limitation, those set forth on the Plat and any planned unit development plat of Royal Ridge Subdivision providing that such provisions do not underlie the Residence and will not interfere with Purchaser's intended use of, access to. or occupancy, of the Property.

The conveyance and assignment of the Property is not (and shall not be deemed to be) a conveyance of the fee simple title to the land.

Assignee/Grantee, by its acceptance and execution of this Agreement, hereby expressly agrees to assume (on a non-recourse basis) all rights and obligations of the Lessee pursuant to the terms of the Ground Lease, with respect to the Property being conveyed and assigned by this Agreement to Assignee/Grantee (including the obligation to pay in accordance with Section 3.1(e) of the Ground Lease, 1/151 of the Ground Rent due to Lessor under the Ground Lease and to perform all of the terms, covenants, conditions, agreements and obligations of Lessee to be performed or fulfilled under the Ground Lease with respect to the Property being conveyed and assigned by this Agreement to Assignee/Grantee and with respect to the Common Area in common with all of the other Unit Owners). The terms "Lessee", "Ground Rent", "Common Area" and "Unit Owners" used in tois paragraph shall have the meanings set forth in the Ground Lease. Assignee/Grantee further agrees that the interests conveyed and assigned by this Agreement as the Property are not and shall not be separately transferable, and any attempted conveyance or assignment of one or more (but less than all) of such interests comprising the Property shall be deemed to be a conveyance and assignment of all interests comprising the Property.
