This Agreement, in exchange for good and valuable consideration is entered in between Gabriel Rangel, Miriam Rangel, Eliodoro Rangel and Reyna Rangel and states as follows:

- 1. Gabriel and Miriam shall pay to Eliodoro and Reyna the sum of \$16,100.00.
