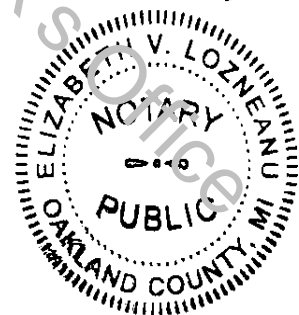



PARCEL 1: LOT 563 (EXCEPT THE EAST 20 FEET THEREOF) IN SWENSON BROTHERS FOURTH ADDITION TO COLLEGE HILL, BEING A SUBDIVISION IN THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 14, TOWNSHIP 41 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, TOGETHER WITH THAT PART OF VACATED CENTRAL PARK AVENUE LYING BETWEEN THE WEST LINE OF THE SOUTHEAST QUARTER OF SECTION 14, AFORESAID, AND THE WEST LINE OF LOT 563, AFORESAID, AND NORTH OF THE NORTH LINE OF THE 16 FOOT ALLEY SOUTH OF AND ADJOINING LOT 563, AFORESAID, EXTENDED WEST AND SOUTH OF THE SOUTH LINE OF GROVE STREET, EXTENDED WEST AS LAID OUT IN THE AFORESAID SWENSON BROTHERS FOURTH ADDITION.
