ORDER OF PERMANENT INJUNCTION

This matter coming on to be heard on the regular trial call, the Court having jurisdiction over the parties and having heard evidence and testimony that the following items in the City's complaint are not complied to date, to wit:

all violations

1. Defendant(s) William Vager his/her/their agents, heirs, successors or assigns are permanently enjoined and restrained from renting, leasing, using, or occupying the entire premises at 1521 S Kolin until full compliance with the City of Chicago Codes as stated in this cause and further order of court, and shall keep the same vacant and secured until full compliance.
2. ~~Defendant shall arrange an interior inspection of the building within 7 days after each compliance date stated in this order. Defendant shall call the inspector at 746 or send written request to the Department of Buildings.~~
3. This order hereby modifies the injunction entered 6/5/2000.
This matter is off the court's call. The court reserves jurisdiction of this matter for the purposes of modification, enforcement or termination of this permanent injunction, including the adjudication of contempt proceedings if the permanent injunction is violated which could result in the imposition of a fine and/or incarceration.

4. This order is final and appealable, the court finding no just cause or reason to delay its enforcement or appeal.
