NOW COMES THE CITY OF EVANSTON, an Illinois municipal corporation, 2100 Ridge Avenue, Evanston, Illinois 60201, by Stanley Janusz, Assistant Director, Property Standards/Housing Rehabilitation, and claims a lien in the amount of Two Thousand Three Hundred Ninety Eight and No/100 Dollars (\$2,398.00). Said lien is claimed pursuant to the police powers of a home rule unit of local government to protect the public health, welfare, and safety and the occupants of a structure by closing and securing said structure when its condition imperils life, safety, or health. The subject structure is at 125-27 Callan Avenue, Evanston, Illinois 60201, which was secured and boarded-up on or about April 16, 2001. 125-127 Callan is legally described as follows:





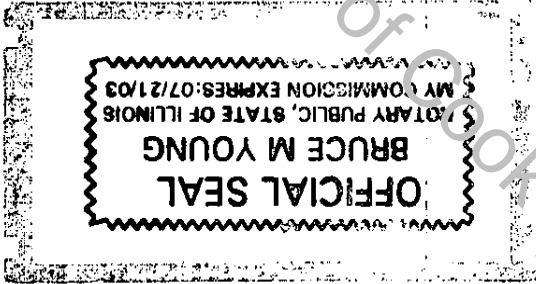
