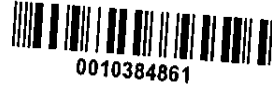

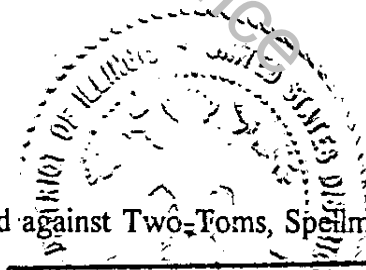
JUDGMENT ORDER
