

Payments are due at such other location as may be designated by Lender in accordance with the notice provisions in Section 15. Lender may return any payment or partial payment if the payment or partial payment is insufficient to bring the Loan current. Lender may accept any payment or partial payment if the payment or partial payment is sufficient to its rights to refuse such payment or partial payment but Lender is not obliged to apply such payment or partial payment at the time such payment is received. If each Periodic Payment is applied as of its scheduled due date, then Lender need not pay interest on unpaid funds. The Funds shall be held in an institution whose deposits are insured by a federal agency, instrumentality, or entity (including Lender, if Lender is an institution whose deposits are so insured) or in any Federal Home Loan Bank.
