WHEREAS, on June 22, 1999, LaSalle filed in the Circuit Court of Cook County, Illinois, County Department, Chancery Division its Verified Complaint to Foreclose Mortgage against the Boykins, which Complaint was served personally on the Boykins and by publication on unknown owners and non-record claimants, and which proceeding is known and captioned as LaSalle Bank FSB v. Lonzo Boykin, et al., Case No. 99 CH 9139 (the "Foreclosure Proceeding"); and

WHEREAS, on September 17, 1999, a Judgment of Foreclosure and Sale ("Judgment") was entered by the Court in the Foreclosure Proceeding; and

WHEREAS, on or about May 19, 1999, the Boykins entered into an Installment Agreement for Warranty Deed (the "Installment Agreement") with Wanda Minley ("Purchaser") with respect to the Property, which Installment Agreement was recorded on June 1, 1999, in the office of the Cook County Recorder of Deeds on June 1, 1999, as Document 99524583; and

WHEREAS, among other things, the Installment Agreement required Purchaser to make monthly payments to LaSalle in the amount of \$2,985.54, the amount of the Boykins monthly payment due to LaSalle under the Note; and

WHEREAS, Purchaser is in default of the Installment Agreement in that Purchaser has failed to make any of the payments due under the Installment Agreement; and

WHEREAS, LaSalle as the holder of the Certificate of Sale desires to terminate the Installment Agreement due to Purchaser's default thereunder;

ACCORDINGLY, NOTICE IS HEREBY GIVEN that the Purchaser under the Installment Agreement is and continually has been in default under the Installment Agreement since the execution and delivery thereof, and that the Installment Agreement is therefore terminated and of no further force or effect.
