

Commencing at the southeasterly corner of 25<sup>th</sup> Avenue as per Plat of Dedication recorded on February 11, 1930 as Document Number 10591812, and Crescent Drive as per Plat of Dedication recorded on August 31, 1961 as Document Number 18243707; thence on as assumed bearing of South 00 degrees 00 minutes 00 seconds East 27.620 meters [90.62 feet] along the east right of way line of said 25<sup>th</sup> Avenue to the point of beginning; thence North 90 degrees 00 minutes 00 seconds East 6.000 meters [19.69 feet]; thence South 00 degrees 00 minutes 00 seconds East 32.601 meters [106.96 feet] to the southwesterly line of the Grantors property; thence North 46 degrees 17 minutes 45 seconds West 8.300 meters [27.23 feet] along the southwesterly line of said Grantors property to said east right of way line of said 25<sup>th</sup> Avenue; thence North 00 degrees 00 minutes 00 seconds West 26.867 meters [88.15 feet] to the point of beginning, all in Cook County, State of Illinois.
