5. Hazard Insurance. Borower that leep the improvements how existing or bereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and such other hazards as Lender may require and in such amounts for such periods as Lender may require.

The insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lender; provided, that such approval shall not be unreasonably withheld. ## NON-UNIFORM COVENANTS Roppover and Lender furnier dovernant and agree as follows:

- 17. Acceleration; Remedies.
