RECAPTURE AGREEMENT

This RECAPTURE AGREEMENT (this "Agreement") dated as of the 2nd day of 100, 2006, riede by 100 martha 30 ton [and]

([collectively,] the "Owner") whose address is 134 E. 104th Stroot, Chicago, Illinois, to the 101mous Community action 11100. ("Grantor"), whose address is 101 n. 16th St. Sprung 2001, Illinois.

WITNESSETH:

WHEREAS, the Owner is the holder of legal title to improvements and certain real property commonly known as 734 & 104th Street. Cheore, Illinois (the "Residence"), legally described in Exhibit A alreaded to and made a part of this Agreement; and

WHEREAS, Grantor has agreed to make a grant to the Owner in the amount of Tour thousand Earthured and No/100 Dollars (\$\frac{1898}{200}\) (in a "Grant"), the proceeds of which are to be used for the rehabilitation of the Residence; and

WHEREAS, as an inducement to Grantor to make the Grant, the Owner has agreed to enter into this Agreement in accordance with the terms, conditions and covenants set forth below.

NOW, THEREFORE, the parties agree as follows:

- 1. <u>Incorporation</u>. The foregoing recitals are made a part of this Agreement.
- 2. Restrictions. As a condition of the Grantor's making of the Grant, the Owner agrees that if the Residence is sold or otherwise transferred within five (5) years of the date of this Agreement (the "Restriction Period"), other than by will, inheritance or by operation of law upon the death of a joint tenant owner, the Owner shall pay to Grantor an amount equal to the amount of the Grant multiplied by a fraction, the numerator of which is the number of full months remaining in the Restriction Period and the denominator of which is sixty (60).

joint tenant owner, the Owner shall pay to Grantor the amount of the Grant less twenty percent (20%) of the amount of the Grant for each full year the Owner has lived in the Residence from the initial date of the Restriction Period. A year in which the Owner has lived in the Residence for more than six (6) months shall count as a full year.

- 3. <u>Amendment</u>. This Agreement shall not be altered or amended without the prior written approval of Grantor.
- 4. <u>Counterparts</u>. This Agreement may be executed in counterparts, and each counterpart shall, for all purposes for which an original of this Agreement must be produced or exhibited, be the Agreement, but all such counterparts shall constitute one and the same agreement.
