**AGREEMENT TO AMEND AND RESTATE
PARTICIPATION AGREEMENT, JUNIOR NOTE
AND JUNIOR MORTGAGE**

(Single-Family Rehabilitation Program)

Project Number: 99-115-15

This Agreement is entered into effective October 25, 2000 by and between the West Suburban Neighborhood Preservation Agency, an Illinois intergovernmental agency (the "Lender") and Robert A. Manzo, single never married (the "Mortgagors").

WHEREAS, the West Suburban Neighborhood Preservation Agency and the Mortgagors executed a Single-Family Rehabilitation Program Owners Participation Agreement the ("Agreement") dated May 5, 2000 to provide the Mortgagors with a loan for the purpose of providing the Mortgagors with funds sufficient to rehabilitate their home.

WHEREAS, the Mortgagors have executed and delivered to the West Suburban Neighborhood Preservation Agency a Junior Mortgage Note dated May 5, 2000 wherein the Mortgagors promise to pay to the order of the West Suburban Neighborhood Preservation Agency the principal sum of Forty-Six Thousand One Hundred Twenty and 00/100 Dollars (\$46,120.00) (the "Note") in repayment of a loan to the Mortgagor from the owners in like amount, together with interest thereon (the "Loan"), in installments as set forth therein.

WHEREAS, the Mortgagors also executed and delivered to the Agency a Junior Mortgage (the "Mortgage") dated May 5, 2000, and recorded on July 3, 2000 as document #00494106, to secure the indebtedness set out in the Note which Mortgage conveyed an interest in the property as described herein:

Lots 12 and 14 in block 6 in East Lawn addition to Maywood, a subdivision of the south 20 acres of the west 60 acres of the Northeast 1/4 of section 3, township 39 north, range 12 east of the third principal meridian, in Cook County, Illinois.

WHEREAS, (\$51,670.00) was expended on the rehabilitation project, and, therefore, the Mortgagors and the Agency wish to amend and restate the Junior Note and the Junior Mortgage to correct the amount of the funds secured by the Junior Note.

WHEREAS, the West Suburban Neighborhood Preservation Agency and the Mortgagors both wish to correct the property record in relation to the Mortgage.

NOW, THEREFORE, in consideration of the mutual covenants and promises contained herein, the parties agree as follows:

1. **RECITALS**

That the foregoing recitals are incorporated herein and made a part hereof by reference.


2. **AMOUNT OF LOAN, NOTE AND MORTGAGE**

That the West Suburban Neighborhood Preservation Agency and the Mortgagors hereby agree that the principal amount of the Agreement, Junior Note and Junior Mortgage shall be amended and restated to be Fifty One Thousand Six Hundred Seventy and 00/100 Dollars (\$51,670.00) and shall no longer be the amount of Forty-Six Thousand One Hundred Twenty and 00/100 Dollars (\$46,120.00).

3. **REMAINING TERMS, CONDITIONS AND COVENANTS**


