### EXHIBIT "A" LEGAL DESCRIPTION

### Parcel 1:

Unit 705 and Parking Space Unit G-16 in 1429 North Wells Condominium as delineated on a survey of the following described premises:

Lot 2 (except the East 172 feet thereof), Lot 3 and Lot 5 (except the South 25 feet of the West 100 feet thereof) in the County Clerk's Resubdivision of Lot 117, in Bronson's Addition to Chicago in the Northeast ¼ of Section 4, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois, also the South 25 feet of the West 100 feet of the South ½ of Section 4, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.
