Exhibit B of the Declaration (Percentage Ownership Interest in the Common Elements) is amended by deleting, in its entirety, Exhibit B attached hereto and substituting in its place attached Exhibit B to show the amended percentage interest in Common Elements increasing the number of Units from one hundred fifty two (152) to one municipal seventy nine (179)

- D. Declarant expressly reserves the right to amend the Plat of Survey for the parcel annexed herein to include additional Units and Limited Common Elements as may be constructed on said parcel.

- It is expressly understood and agreed by and between the parties hereto, anything 3. herein to the contrary notwithstanding, that each and all of the representations. covenants, undertakings, warranties and agreements herein made on the part of the Declarant while in form purporting to be the representations, convenants, undertakings, war:anties and agreements of the Declarant are nevertheless each and every one of them, made and intended not as personal representations, covenants, undertakings, warranties, and agreements by the Declarant or for the purpose or with the intention of binding the Declarant personally but are made and intended for the purpose of binding only that pertien of the property specifically described herein, and this instrument is executed and doin ered by the Declarant not in its own right, but solely in the exercise of the powers conferred upon it as such Declarant; and that no personal liability or personal responsibility is assumed by nor shall at any time be asserted or enforceable against Declarant, on account of this instrument or on account of any representation, covenant, undertaking, warranty, or agreement of the Declarant in this instrument contained, either expressed or implied, all such personal liability, if any, being expressly waived and released. The Declarant makes no personal representations as to nor shall it be responsible for the existence, location or maintenance of the chattels herein described, if any.
- 4. Except as herein specifically amended, the Ceclaration is ratified and confirmed. In the event of any inconsistency between this Third Amendment and the Declaration, this Fourth Amendment shall control.
- All defined terms herein shall have the meanings contained in the Declaration.
