The undersigned

further states that this covenant shall run with the land and shall be binding upon all subsequent grantees. This covenant is made to induce the City of Chicago to furnish sewer and water service to the above described premises.

This instrument is executed by SUBURBAN BANK & TRUST CO., not personally but solely as Trustee, as aforesaid, in the exercise of the power and authority conferred upon and vested in it as such Trustee. All the terms, provisions, stipulations, covenants and conditions to be performed by SUBURBAN BANK & TRUST CO., are undertaken by it solely as Trustee, as aforesaid, and not individually and all statements herein made are made on information and being and are to be construed accordingly, and no personal liability shall be asserted or be enforceable against SUBURBAN BANK & TRUST CO., by reason of any of the terms, provisions, stipulations, covenants and/or statements contained in this instrument.
