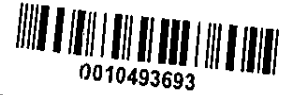



MORTGAGE

THIS MORTGAGE IS DATED AUGUST 26, 1999, between WILLIAM C SUENKENS and PAMELA M SUENKENS, HUSBAND AND WIFE, whose address is 5428 S KEDVALE, CHICAGO, IL 60632 (referred to below as "Grantor"); and OLD KENT BANK, whose address is 232 S WACKER DR, CHICAGO, IL 60606 (referred to below as "Lender").

GRANT OF MORTGAGE. For valuable consideration, Grantor mortgages, warrants, and conveys to Lender all of Grantor's right, title, and interest in and to the following described real property, together with all existing or subsequently erected or affixed buildings, improvements and fixtures, all easements, rights of way, and appurtenances; all water, water rights, watercourses and ditch rights (including stock in utilities with ditch or irrigation rights); and all other rights, royalties, and profits relating to the real property, including without limitation all minerals, oil, gas, geothermal and similar matters, located in COOK County, State of Illinois (the "Real Property"):

LOT 10 IN BLOCK 3 IN OLIVER SALINGER AND COMPANY'S CRAWFORD AVENUE AND 5TH STREET SUBDIVISION, BEING A SUBDIVISION OF PART OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER OF SECTION 10, TOWNSHIP 38 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING SOUTH OF INDIANA HARBOR BELT RAILROAD RIGHT OF WAY, IN COOK COUNTY, ILLINOIS.

The Real Property or its address is commonly known as 5428 S KEDVALE, CHICAGO, IL 60632. The Real Property tax identification number is 19-10-419-025.

Grantor presently assigns to Lender all of Grantor's right, title, and interest in and to all leases of the Property and all Rents from the Property. In addition, Grantor grants to Lender a Uniform Commercial Code security interest in the Personal Property and Rents.
