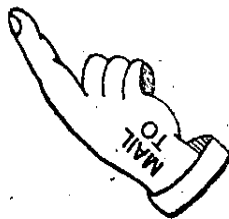

LaSalle Street, Chicago, IL 60602, the owner of record of the LAND (collectively "OWNER"), which is commonly known as Chicago Midway Municipal Airport ("Midway"), 5700 S. Cicero, Chicago, Illinois, the legal description of which is:

ALL OF SECTION 16, TOWNSHIP 38 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

Claimant also hereby files a Notice and Claim for Lien against GILMAN CONSTRUCTION COMPANY, INC., 11201 S. Talman, Chicago, IL 60655 ("GILMAN"), who on information and belief was the general contractor for said project; who was authorized and/or knowingly permitted by DELTA to provide construction work for tenant improvements at Midway.


On or before February 2, 2001, the DELTA made a contract with GILMAN whereby GILMAN was to provide, or knowingly permitted GILMAN to provide labor, material, tools and equipment for construction for said project and on or about February 2, 2001, GILMAN and CAIN entered into a written subcontract whereby CAIN was to provide architectural millwork labor, materials, tools and equipment for said project; CAIN thereafter completed all of its obligations pursuant to said subcontract on or about February 28, 2001.

To date, despite due demand for payment, Claimant remains unpaid for said work; and there is no reasonable basis for the failure to pay CAIN.

Therefore, after all due credits, the amount left due, unpaid and owing to CAIN is \$29,745.00, for which amount, plus interest and collection costs, including reasonable attorneys' fees, CAIN claims a lien against DELTA's leasehold interest at Midway and improvements thereon, and on any monies due or to become due to GILMAN or any other party from DELTA for said project.

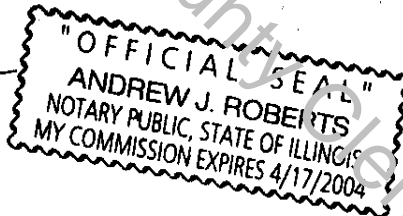
