

If a corporation acts as incorporator, the name or the corporation and the state of incorporation shall be shown and the execution shall be by its President or Vice-incorporation and verified by him, and attested by its Secretary or an Assistant Secretary.


The registered agent cannot be the corporation itself.

The registered agent may be an individual, resident in this State, or a domestic or foreign corporation, authorized to act as a registered agent.

The registered office may be, but need not be, the same as its principal office.

A corporation which is to function as a club, as defined in Section 1-3.24 of the "Liquor Control Act" of 1934, must insert in its purpose clause a statement that it will comply with the state and local laws and ordinances relating to alcoholic liquors.
