WHEREAS, the parties hereto for mutual consideration wish to revise the terms of the Note and Mortgage of said indebtedness;

NOW THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

It is agreed that as of the date of this Modification, the unpaid principal balance of sald indebtedness is Three Hundred Seventy-six Thousand Three Hundred Twenty-one And 29/100th Dollars (\$376,321.29).

The Note and Mortgage dated October 15, 1999 shall be modified to provide for an additional advance of funds not to exceed the amount of Twenty Thousand Six Hundred Seventy-eight and 71/100ths Dollars (\$20,678.71).

Mid America will (und an Additional Advance of Twenty Thousand Six Hundred Seventy-eight and 71/100ths Dollars (\$20,678.71) which shall increase the unpaid principal balance of sald indebtedness to Three Hundred Ninety-seven Thousand and 00/100ths Dollars (\$397,000.00).

As of March 1, 2001, the modified interest rate the Borrowers are required to pay will be 7.25%.

This modified interest rate will remain constant for the remaining term of the loan. The principal and interest payment based on the rate indicate 1 shove will be \$2744.08. The Borrowers shall make the new modified payments on the first day of each month, beginning on April 1,2001.
