Memorandum of Lease and Option

Between Mike Noonan ("Landlord")

and Cook Inlet/VoiceStream PCS, LLC, a Delaware limited liability company ("Tenant")

A Site Lease with Option ("Lease") dated hobrania, 2000 by and between Mike Noonan ("Landlord") and Cook Inlet/VoiceStream PCS, LLC ("Tenant") was made regarding the following property:


