3. Funds for Escrow Items. All insurance policies required by Lender and renewals of such policies shall be subject to Lender's right to disapprove such policies, shall include a standard mortgage clause, and shall name Lender as mortgagor as an additional loss payee. Lender shall have the right to hold the policies and renewals certificates. If Lender requires, Borrower shall promptly give to Lender all receipts of paid premiums and renewal notices. If Borrower obtains any form of insurance coverage, not otherwise required by Lender, for damage to, or destruction of, the Property, such policy shall include a standard mortgage clause and be applied to restoration or repair of the Property, if the restoration or repair is economic feasible and Lender's security is not lessened. 
