SPLCIAL WARRANTY DEED

Together with all and singular the hereditaments and appurtenances thereunto belonging, or in anywise appertaining, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof, and all the estate, right, title, interest, claim or demand whatsoever, of the Grantor either in law or equity, of, in and to the above described premises, with the

hereditaments and appurtenances: TO HAVE AND TO HOLD the said premises as above described, with the appurtenances, unto the Grantee, its successors and assigns forever.

Grantor also hereby grants to the Grantee, its successors and assigns, as rights and easements appurtenant to the subject Unit described herein, the rights and easements for the benefit of said Unit set forth in the Declaration of Condominium recorded as Document No. 0010323763; and Grantor reserves to itself, its successors and assigns, the rights and easements set forth in said Declaration for the benefit of the remaining land described therein.

This Deed is subject to all rights, easements, covenants, restrictions, and reservations contained in said Declaration the same as though the provisions of said Declaration were recited and stipulated at length herein.

And the Grantor, for itself and its successors, does covenant, promise and agree, to and with the Grantee, that it has not done or suffered to be done, anything whereby the said premises hereby granted are, or may be, in any manner encumbered or charged, except as herein recited; and that the said premises, against all persons lawfully claiming, or to claim the same, by, through or under it, Grantor WILL WARRANT AND DEFEND, subject to the Permitted Exceptions appearing on Exhibit B which is attached hereto and made a pan nereof.

Grantor also hereby releases and waives all rights under and by virtue of the Homestead Exemption Laws of the State of Illinois.

- 3. The provisions of the Condominium Declaration recorded as Document No. 0010323763 including all amendments and exhibits thereto.
- 4. Applicable zening and building laws and ordinances and other ordinances of record.
- 5. Fence encroachments, if any.
- 6. Acts done or suffered by Crantee or anyone claiming by, through or under Grantee.
- 7. Leases and licenses affecting the Common Elements as defined in the Condominium Declaration.
- 8. Covenants, conditions, agreements, buildin; lines and restrictions of record.
- 9. Easements recorded at any time prior to Closing, including any easements established by or implied from the Condominium Declaration or amendments thereto.
- 10. Liens, encroachments and other matters over which the Greater Illinois Title Company is willing to insure over at Grantor's expense; provided, however, that the title exceptions described in 5, 7, 8, or 9 above shall not prohibit the Grantee's use of the Unit as a single-family residence.
