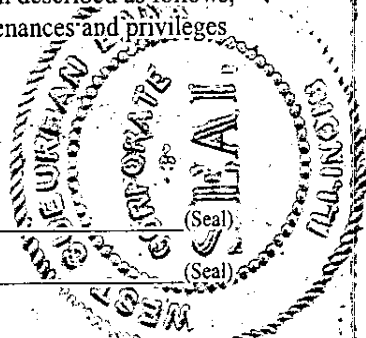

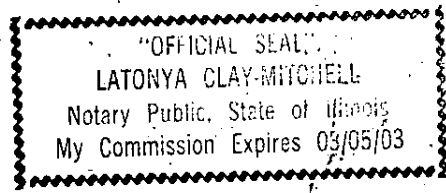

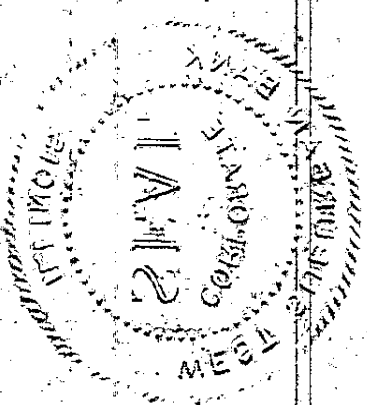

LEGAL DESCRIPTION
