2. **Application of Payments or Proceeds.** Except as otherwise described in this Section 2, all payments accepted and applied by Lender shall be applied in the following order of priority: (a) interest due under the Note; (b) principal due under the Note; (c) amounts due under Section 3. Such payments shall be applied to each Periodic Payment in the order in which it became due. Any remaining amounts shall be applied first to late charges, second to any other amounts due under this Security Instrument, and then to reduce the principal balance of the Note.

**UNIFORM COVENANTS.** Bottower and Lender covenant and agree as follows:

**THIS SECURITY INSTRUMENT** combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.

**3. 5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakes and floods, for which Lender requires insurance. This insurance shall be maintained in the amounts

Lender may require Borrower to pay a one-time charge for a real estate tax re-estimation and/or reporting service used by Lender in connection with this Loan.

Borrower shall promptly discharge any Lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the payment of the obligation secured by the Lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreements; (b) conveys the Lien in good faith by, or delegates as agent his enforcement of the Lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the Lien while those proceedings are pending, but only until such proceedings are concluded; or (c) secures from the holder of the Lien an agreement satisfactory to Lender substantiating the Lien to this Securitry Instrument. 8. **Borrower's Loan Application.** Borrower shall be in default if, during the Loan application or statements to Lender (or failed to provide Lender with material information) in which Borrower's knowledge or consent gave materially false, misleading, or inaccurate application process, Borrower or any persons or entities acting at the direction of Borrower or specifying such reasonable cause.




