### MEMORANDUM OF AGREEMENT

This Memorandur of Agreement is entered into on this day of west Ogden Avenue, Lyons, Illinois 60534, (hereinafter referred to as "Lessor") and Nextel West Corp., a Delaware corporation, d/b/a Nextel Communications with an office at 400 West Grand Avenue, Elmhurst, Illinois 60126 (hereinafter referred to as "Lessee").

- 1. Lessor and Lessee entered into a Communications Site Lease Agreement (Building) ("Agreement") on the \_\_\_\_\_ day of \_\_\_\_\_\_\_, 200'., for the purpose of installing, operating and maintaining a radio communications facility and other improvements.
