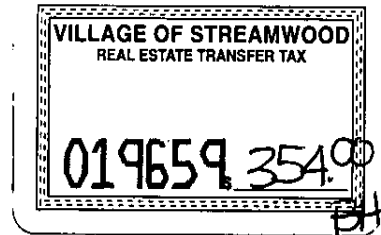
**TRUSTEE'S DEED
