RE-ESTABLISH INITIAL THREE YEAR TERM: TO MODIFY ORIGINAL MORTGAGE TO ALLOW FOR AN ADDITIONAL ADVANCE OF FUNDS IN THE AMOUNT OF \$42,612.47; TO MODIFY PRINCIPAL AND INTEREST FROM \$1945.79 TO \$2199.48.

NOW THEREFORE, in consideration of the mutual covenants contained herein, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

It is agreed that as of the date of this Modification, the unpaid principal balance of said indebtedness is Two Hundred Ninety-two Thousand, Seven Hundred Ninety And 36/100 (\$292,790.36).

The Note and Mortgage dated February 9, 1999 shall be modified to provide for an additional advance of funds not to exceed the amount of Forty-two Thousand, Six Hundred Twelve And 47/100 (\$42,612.47).

Mid America will fund an Additional Advance of Forty-two Thousand, Six Hundred Twelve And 47/100 (\$42,612.47) which shall increase the unpaid principal balance of said indebtedness to Three Hundred Thirty-five Thousand, Four Hundred Two And 83/100 (\$335,402.83).

The Borrowers do hereby amend and modify the Note and Mortgage described above by specifically amending Section 2 (Interest), Section 3 (Payments), And Section 4 (Interest Rate And Monthly Payment Changes) of the Note as follows:

As of May 1, 2001, the modified interest rate on the loan will be 8.7% until the next interest rate Change

The adjustable interest rate may change on the first day of May 1, 2004, and on that day every 12th month thereafter. Each date of which the adjustable rate could change is called a "Change Date". The interest rate the Borrowers are remired to pay at the next Change Date will not be greater than 8.75% or less than 4.75%. Thereafter, Borrower interest rate will never be increased or decreased on any single Change Date by more than Two percentage point, (2.00%) from the rate of interest the Borrowers have been paying for the preceding twelve months. The Corrowers interest rate will never be greater than 12.75%. Calculation of changes in the interest rate shall be according to the terms of the Note.

The principal and interest payment base on the rate indicated above will be \$2199.48. The Borrowers shall make the new modified payments on the first day of each month beginning on June 1, 2001.

It is agreed that all sums owed under the Note will be paid no later than March 1, 2029 ("the Maturity Date") and the Maturity Date under all the Loan Dotumerts will be deemed March 1, 2029. To the extent the terms, conditions and provisions of this Modification lifter from or are inconsistent with the Note, Mortgage or other Loan Documents executed by the Borrowers, the carms, conditions and provisions of this Modification 0210578360 , shall control and govern.
