GOO'DSELL DECLARATION OF TRUST DATED OCTOBER 27, 2000, 429 Cherry Lane, Glenview, Illinois 60025 (hereinafter referred to as "said trustee", regardless of the number of trustees) and unto all and every successor or successors in trust under said declaration of trust, the following described real estate in the County of Cook and State of ill nois, to-wit:

Lot 43 in Nixon's Greenwood Central Development Unit C, being a subdivision of part of the East Half (E-1/2) of the Northeast Fraction: I Quarter of Section 10 and part of the West Half (W-1/2) of the Northwest Fractional Quarter of Section 11, Township 41North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois

The interest reach and every beneficiary hereunder and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to sold real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid.

And the said grantors hereby expressly waive and release any and all right or benefit under and by virtue of any and all statutes of the State of Illicois, providing for the exemption of homesteads from sale on execution or otherwise.
