5. Hazard Insurar ce. I for over shall beep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards metuded within the term "extended coverage," and such other hazards as Lender may require and in such amounts for such periods as Lender may require.

The insurance carrier providing the insurance shall be chosen by Borrower subject to approval by Lender; provided, that such approval shall not be unreasonably withheld. - 11. Successors and Assigns Hound fein and several Liability; Co-Signer The covenants and agreements herein contained shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Lender and Borrower, subject to the provisions of paragraph 16 hereof.
