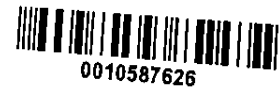


Warranty Deed

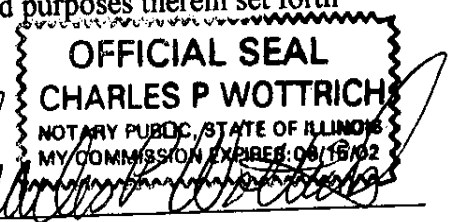

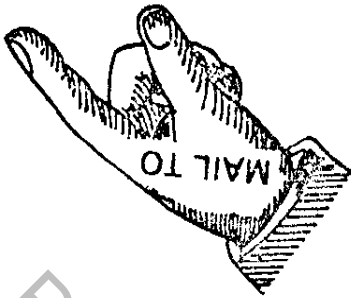
