

(E) Effective Date of Changes

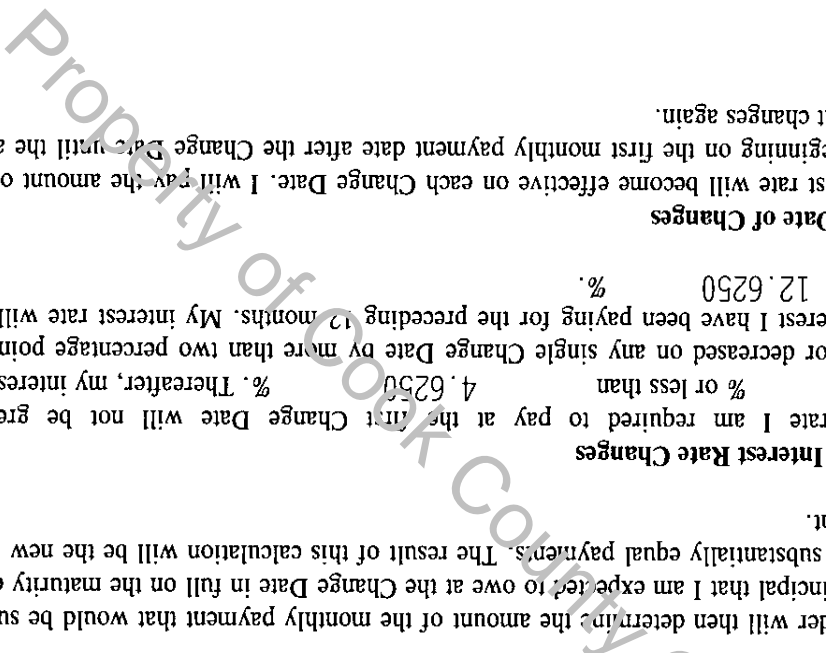
