
LIS PENDENS NOTICE

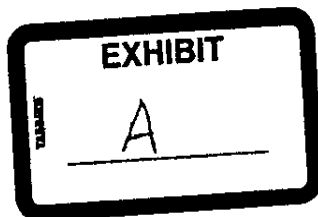
