AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE METROPOLITAN PLACE CONDOMINIUM

This Amendment to Declaration of Condominium Ownership and of Easement. Restrictions, Covenants and By-Laws for The Metropolitan Place Condominium Association (hereinafter referred to as "Amendment") is made and entered into as of May 15, 2001 by the Board of Directors of the Metropolitan Place Condominium Association (hereinafter referred to as "Board") and the Owners of Units 407 and 10P located in the Metropolitan Place Condominium.

- A. - B. The parties hereto desire to transfer the Limited Common Element parking space number 108, originally assigned as an exclusive Limited Common Element for Unit 407 to an exclusive Limited Common Element for Unit 10P.
- C. Pursuant to Section 26 of the Illinois Condominium Property Act (hereinafter referred to as "Section 26), Limited Common Elements may be transferred between Unit Owners by an Amendment executed by all Unit Owners who are parties to the transfer and by all other Unit owners who have any right to use the Limited Common Elements affected, and

containing a certificate showing that a copy of the Amendment has been delivered to the Board.

- D. This Amendment has been signed by all parties to the transfer and by all Unit Owners having any right to use the Limited Common Element parking space being transferred and has been delivered to the Board pursuant to Section 26. The transferor and transferee herein are all of the unit owners that are parties to this transfer and are in agreement that no change will occur as a result of this transfer in the existing percentages of ownership interest in the common elements attributable to their respective Units.
- Now, therefore, the Declaration is hereby amended as follows:
- 1. The Limited Common Element parking space numbered 108, originally assigned to Unit 407, is assigned to Unit 10P, thereby reserving its exclusive use to Unit 10P to the exclusion of all other Upics.
- 2. All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Declaration.
- 3. This Amendment may be signed in any number of counterparts.
- 4. Except as specifically amended hereby, the Declaration remains unmodified, in full force and effect and is hereby ratified and confirmed. All references to the Declaration shall mean and refer to the Declaration as amended hereby.
