

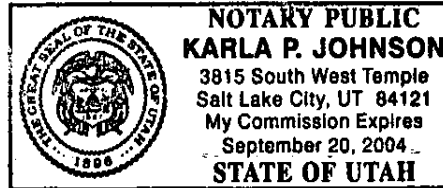

LEGAL DESCRIPTION
