ORDER

THIS CAUSE coming on to be heard pursuant to the Order entered April 19, 1999 for allocation of responsibility for payment to Schiller, DuCanto and Fleck in the amount of \$26,065, the Court having heard the arguments of counsel and being fully advised in the premises;

IT IS HEREBY ORDERED:

1. That judgment is hereby entered in favor of the law firm of Schiller, DuCanto and Fleck against Jeffrey Zarem for \$19,548.75 which represents 75% of the \$26,065 balance due and owing Schiller, DuCanto and Fleck.

2. That Debra Zarem shall be responsible for payment of \$6,516.25 which represents 25% of the \$26,065 owed to Schiller, DuCanto and Fleck. If Debra has not paid the law firm of Schiller, DuCanto and Fleck the sum of \$5,000 on or before May 21, 1999, the law firm of Schiller, DuCanto and Fleck shall elect to accept either installment payments in the amount of \$100 per month until the total sum of \$6,516.25 has been paid, or the entry of judgment in the firm's favor against Debra Zarem in the amount of \$6,516.25.
