



FOURTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE MICHIGAN INDIANA CONDOMINIUM

THIS FOURTH AMENDMENT, executed as of JUNE 1, 2001 by Michigan Place LLC, an Illinois limited liability company (hereinafter referred to as "Developer"),

WITNESSETH:

WHEREAS. Developer has executed that certain DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE MICHIGAN INDIANA CONDOMINIUM dated FEBRUARY 23, 2001 and recorded by the Cook Country Recorder of Deeds on March 15, 2001 as document 001-0205852 as arriended by that certain FIRST AMENDMENT TO DECLARATION OF CONDUMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE MICHIGAN INDIANA CONDOMINIUM dated APRIL 2, 2001 and recorded by the Cook Country Recorder of Deeds on April 6, 2001 as document 001-0278713 and by that certain SECOND AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR THE MICHIGAN INDIANA CONDOMINIUM dated APRIL 20, 2004 and recorded by the Cook Country Recorder of Deeds on April 27, 2001 as document 001-0349638 and by that certain THIRD AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS, COVENANTS AND EY-LAWS FOR THE MICHIGAN INDIANA CONDOMINIUM dated MAY 3, 2001 and recorded by the Cook Country Recorder of Deeds on May 17, 2001 as document 001-0418003 (as so amended, "the Declaration"); and

WHEREAS, Article Fourteen of the Declaration permits Developer to amend the Declaration to annex thereto additional property in the Future Development Parcel; and

WHEREAS, Developer desires and intends by this Fourth Amendment to annex additional property to the Declaration;

NOW, THEREFORE, Developer, as the holder of the Leasehold Estate and leasehold interest in the Parcel pursuant to the Ground Lease AMENDS THE DECLARATION AS FOLLOWS:

1. **DEFINED TERMS**: All capitalized terms in this Fourth Amendment shall have the same meanings ascribed to such terms in the Declaration.

- 2. PROPERTY: The property legally described on Exhibit "B" attached to this Fourth Amendment is hereby and shall be deemed submitted to the Act and governed in all respects by the provisions of the Declaration and is and shall become part of the Property and henceforth "Property" for purposes of Paragraph 28 of Article One shall mean the property legally described on Exhibit "B" attached to this Fourth Amendment, together with the property legally described on Exhibit "B" to the Declaration prior to the execution of this Fourth Amendment.
- 3. **PERCENTAGE INTERESTS**: Exhibit "C" to the Declaration is deleted and replaced by Exhibit "C" to this Fourth Amendment.
- 4. **LIMITED COMMON ELEMENTS**: Exhibit "D" to the Declaration is deleted and replaced by Exhibit "D" to this Fourth Amendment.
- 5. FUTURE DEVELOPMENT PARCEL: Exhibit "E" to the Declaration is deleted and replaced by Exhibit "E" to this Fourth Amendment.
- 6. RATIFICATION OF DECLARATION AS AMENDED: Developer hereby ratifies and affirms the Declaration as amended by this Fourth Amendment.
