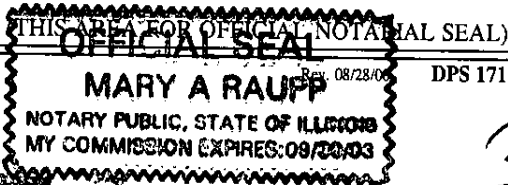

THE NORTH 33.44 FEET OF THAT PART OF LOT 41 (EXCEPT THE EAST 8 FEET THEREOF, AS MEASURED ALONG THE NORTH AND SOUTH LINE OF LOT 41 AND THE EAST 12.50 FEET OF LOT "B", AS MEASURED ALONG THE NORTH AND SOUTH LINE OF LOT "B", TAKEN AS A TRACT, LYING SOUTH OF A STRAIGHT LINE DRAWN WESTWARD FROM A POINT ON THE EAST LINE OF LOT 42, WHICH POINT IS 69.47 FEET SOUTH OF THE NORTHEAST CORNER OF SAID LOT 42 AND PASSING THROUGH A POINT ON THE EAST LINE OF LOT "B", WHICH POINT IS 64 FEET SOUTH OF THE NORTHEAST CORNER OF SAID LOT "B".
