# CONSTRUCTION MORTGAGE AND ASSIGNMENT OF LEASES AND RENTS AND SECURITY AGREEMENT

This Construction Mo.tgage and Assignment of Leases and Rents and Security Agreement (this "Mortgage") is made as of the day of June, 2001, between Commonwealth Properties Company, L.L.C., an Illinois limited liability company (the "Company") and The Chicago Trust Company, as Successor Trustee to Chicago Title and Trust Company as Trustee under Trust Agreement dated April 17, 1974 and known as Trust Number 64203 (the "Trustee"), (hereinafter the Company and the Trustee are referred to jointly as the "Mortgagor") whose address is set forth below in favor of United Community Bank of Lisle, an Illinois banking corporation ("Mortgagee") whose address is set forth below.

Article 1

**DEFINITIONS** 

#### 1.1 Definitions

As used herein, the following terms shall have the following meanings:

- (a) <u>Assignment</u>: The assignment, contained in Article 3 of this Mortgage, from Mortgager to Mortgagee, of all of Mortgagor's right, title and interest in and to the Leases and the Rents.
- (b) Awards: All awards and payments made or hereafter to be made by any municipal, township, county, state, Federal or other governmental agencies, authorities or boards or any other entity having the power of eminent domain to Mortgagor, including, but not limited to, any awards and payments for any taking of all or a portion of the Mortgaged Property, as a result of, or by agreement in anticipation of, the exercise of the right of condemnation or eminent domain, or for any change or changes of grade of streets affecting the Mortgaged Property.

- (c) <u>Borrower</u>: Commonwealth Properties Company, L.L.C. an Illinois limited liability company (the "Company") and Commonwealth Avenue Partnership, A Limited Partnership, an Illinois limited partnership (the "Partnership").
- (d) <u>Building or Buildings</u>: All buildings, improvements, alterations or appurtenances now, or at any time hereafter, constructed or located upon the Land or any part thereof.
- (e) <u>Defaulted Interest Rate</u>: The lesser of (i) the interest rate of Default Rate, as defined in the Notes secured by this Mortgage or (ii) the highest contract rate allowed by law.
- (f) <u>Event(s) of Default</u>: The happenings and occurrences described in Article 5 of this Mortgage.
- (g) <u>Fixtures</u>: All fixtures, systems, or Building equipment located upon or within the Land or Buildings or new or hereafter attached to, or installed in, or used in connection with, any of the Land or Buildings whether or not permanently affixed to the Mortgaged Property.
  - (h) Guarantor: The Person identified in the Loan Agreement as the "Guarantor".
- (i) <u>Guaranty:</u> The limited guaranty of even date executed by the Guarantor guaranteeing fifty percent of the Indebtedness and all of the Obligations under this Mortgage, the Notes (as hereinafter defined), the Loan Agreement and all of the other Loan Documents.
- Hazardous Materials. All hazardous, toxic or dangerous substances, wastes and (i) materials and other pollutants and contaminants as defined or described in any or all applicable federal, state or local statutes, laws, ordinances, codes, rules, regulations, orders or decrees now or hereafter regulating, relating to or imposing liability or standards of conduct with respect to environmental matters, including, without limitation the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended by the Superfund amendments and Reauthorization Act of 1986 (42 U.S.C. §9601 et seq.), the Hazardous Materials Transportation Act (49 U.S.C. § 1801 et see.), the Solid Waste Disposal Act, as amended by the Resource Conservation and Recovery Act of 1976, as amended by the Solid and Hazardous Waste Amendments of 1984 (42 U.S.C. §6901 et seq.), the Federal Water Poliviica Control Act, as amended by the Clean Water Act of 1977 and the Water Quality Act of 1987 (33 U.S.C. §1251 et seq.), the Toxic Substances Control Act of 1976 (15 U.S.C. §2601 et seq.), the Emergency Planning and Community Right-to-Know Act of 1986 (42 U.S.C. §11001 et seq.), the Clear Air Act of 1966, as amended (42 U.S.C. §7401 et seq.), the National Environmental Policy Act of 1970 (42 U.S.C. §4321 et seq.), the Rivers and Harbors Act of 1899 (33 U.S.C. §401 et seq.), the Endangered Species Act of 1973, as amended (16 U.S.C. §1531 et seq.), the Safe Drinking Water Act of 1974, as amended (42 U.S.C. §300(f) et seq.), the Occupational Safety and Health Act of 1970, as amended (29 U.S.C. §651 et seq.) and all rules and regulations promulgated or published thereunder, all as amended or hereinafter amended. Without intending to limit the scope or breadth of the foregoing definition, the term Hazardous Materials shall include asbestos, urea formaldehyde, polychlorinated biphenyls, crude oil, radioactive materials and underground storage tanks. Hazardous Materials shall not include those materials which are

used or stored at the property in the ordinary course of business operations in compliance with Environmental Laws.

- (k) <u>Impositions</u>: All (i) real estate and personal property taxes and other taxes and assessments, water and sewer rates and charges, and all other governmental charges and any interest or costs or penalties with respect thereto, and charges for any easement or agreement maintained for the benefit of the Mortgaged Property which at any time prior to or after the execution of the other Loan Documents may be assessed, levied, or imposed upon the Mortgaged Property or the rent or income received therefrom or any use or occupancy thereof, and (ii) other taxes, assessments, fees and governmental charges levied, imposed or assessed upon or against the Mortgaged Property.
- (1) <u>indebtedness</u>: The principal of and all interest on the Notes and any and all other amounts, payments, sums or premiums due under the Notes or any of the other Loan Documents and all other indebtedness of Borrower or Guarantor to Mortgagee under and/or secured by this Mortgage and by any of the other Loan Documents, or any amendments, modifications, renewals and extensions of any of the foregoing.
  - (m) <u>Land</u>: The real estate described in <u>Exhibit A</u> attached hereto.
- (n) <u>Leases</u>: Any and all leases, subleases, licenses, concessions or grants of other possessory interests now or hereafter in force, oral or written, covering or affecting the Mortgaged Property, or any part thereof, together with all rights, powers, privileges, options and other benefits of Mortgagor thereunder.
- (p) <u>Loan Agreement</u>: The Construction Loan Agreement by and between Mortgagor and Mortgagee dated of even date herewith.
- (q) <u>Mortgaged Property</u>: The Land, the Buildings the Fixtures, the Leases, the Personalty and the Rents together with:
  - (i) all rights, privileges, permits, licenses, tenements, hereditaments, rights-of-way, easements, appendages and appurtenances of the Buildings belonging or in any way appertaining thereto and all right, title and interest of Mortgagor in and to any streets, ways, alleys, strips or gores of land adjoining the Land or any part thereof;
  - (ii) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Land, the Buildings, the Fixtures, the Leases and the Rents; and
  - (iii) all the estate, right, title, interest, claim or demand whatsoever of Mortgagor, either at law or in equity, in and to the Awards, or payments with respect to casualties.
- (r) <u>Mortgagee</u>: United Community Bank of Lisle, its successors and assigns, and the holders, from time to time, of the Notes.

- (v) Notes: Construction Revolving Line of Credit Note in the amount of SEVEN MILLION FIVE HUNDRED THOUSAND AND NO/100 DOLLARS (\$7,500,000.00) ("Construction Note") and the Letter of Credit Note in the amount of ONE HUNDRED FIVE THOUSAND FOUR HUNDRED AND NO/100 DOLLARS (\$105,400.00) ("Letter of Credit Note") each dated of even date with this Mortgage made, jointly and severally, by the Company, the Trustee and the Partnership to the order of Mortgagee and all extensions, modifications, renewals and restatements of any of such Notes.
- (w) Obligations. Any and all of the covenants, promises, agreements, warranties and other obligations (other than the Indebtedness) made or owing by Borrower to or due to Mortgagee under and/or as set forth in this Mortgage or any of the other Loan Documents, and any and all extensions, renewals, modifications and amendments of any of the foregoing.
- (x) Other Loan Documents: The Loan Agreement, the Notes, the Guaranty, the Security Agreement and any and all other locuments executed by the Borrower, or others, including, but not limited to the Guarantor, now or hereafter securing the payment of the Indebtedness or the observance or performance of the Obligations.
- (y) <u>Permitted Encumbrances</u>: The encumbrances described, with particularity, in <u>Exhibit B</u> attached hereto.
- (z) <u>Personalty</u>: All furniture, furnishings, equipment, machinery, trade fixtures and all other personal property (other than the Fixtures) owned by Borrower or any Mortgagor now or hereafter located in, upon or about the Land, the Building, together with all accessions, replacements and substitutions thereto or therefor and the proceeds and produc s thereof.
- (aa) Rents: All of the rents, revenues, income, profits, deposits, tenders and other benefits payable under the Leases and/or arising in any manner from the use and enjoyment of all or any portion of the Mortgaged Property.

All capitalized terms used in this Mortgage which are not specifically defined herein shall have the meaning specified in the Loan Agreement.

Article 2

#### **GRANT**

- 2.1 <u>Grant</u>. To secure the payment of the Indebtedness and the performance and discharge of the Obligations, Mortgagor by these presents hereby grants, bargains, sells, assigns, mortgages, conveys and warrants unto Mortgagee to have and to hold the Mortgaged Property unto Mortgagee, its successors and assigns forever.
- 2.2 <u>Condition of Grant</u>. Provided always, that if Borrower promptly shall pay the entire Indebtedness as and when the same shall become due and payable and shall observe, perform and discharge the Obligations, then the other Loan Documents and the estate and rights hereby granted shall cease, terminate and become void, and shall be released by Mortgagee, at the cost and expense of Borrower, and, in case of failure of the Mortgagee to so release this Mortgage, all claims for statutory penalties are hereby waived.
- 2.3 <u>Doctrine of Merger</u> Upon the foreclosure of this Mortgage, no assigned Lease shall be destroyed or terminated by application of the doctrine of merger or as a matter of law unless Mortgagee or any purchaser at such forcelosure sale so elects. No act by or on behalf of Mortgagee or any such purchaser shall constitute a term ination of any assigned Lease unless Mortgagee or such purchaser gives written notice thereof to the applicable tenant or subtenant.

#### Article 3

### SECURITY INTEREST AND ASSIGNMENT OF LEASES AND RENTS

- 3.1 <u>Security Agreement</u>. This Mortgage shall be construed as a mortgage of a fee simple interest in real property and it shall also constitute a "Security Agreement" within the meaning of, and shall create a security interest under, the Uniform Commercial Code as adopted in the state in which the Mortgaged Property is located (the "UCC"), in the Fixtures.
- 3.2 <u>Security Interest</u>. Mortgagor hereby grants to Mortgagee a security interest under the UCC in the Fixtures and Mortgagee shall have all rights with respect thereto whorded to it by the UCC, in addition to, but not in limitation of, the other rights afforded to Mortgagee by the other Loan Documents.
- 3.3 <u>Financing Statements</u>. Mortgagor agrees to and shall execute and deliver to Mortgagee, in form satisfactory to Mortgagee, such "Financing Statements", if any, and such further assurances as Mortgagee may, from time to time, consider reasonably necessary to create, perfect and preserve Mortgagee's liens upon the Fixtures, and Mortgagee, at the expense of Mortgagor, may or shall cause such statements and assurances to be recorded and re-recorded, filed and re-filed, at such times and places as may be required or permitted by law to so create, perfect and preserve such liens.

Assignment of Leases and Rents. In order to further secure payment of the Indebtedness and the observance, performance and discharge of the Obligations, Mortgagor hereby absolutely and irrevocably assigns and transfers to Mortgagee, all of Mortgagor's right, title and interest in and to the Leases and the Rents, subject only to the Permitted Encumbrances. Mortgagor hereby appoints Mortgagee its true and lawful attorney-in-fact, with the right, at Mortgagee's option at any time, to demand, receive and enforce payment, to give receipts, releases and satisfactions, and to sue, either in Mortgagor's or Mortgagee's name, for all Rents. Notwithstanding the foregoing assignment of Leases and Rents, so long as no Event of Default has occurred which remains uncured, Mortgagor shall have a license (such license to be deemed revoked upon the occurrence of an Event of Default) to collect Rents, provided that the existence or exercise of such right of Mortgagor snal not operate to subordinate this assignment to any subsequent assignment, in whole or in part, by Mortgagor, and any subsequent assignment by Mortgagor shall be subject to the rights of the Mortgagee hereunder. This Assignment shall not be deemed or construed to constitute Mortgagee as a mor gagee in possession nor obligate Mortgagee to take any action or to incur expenses or perform or discharge any obligation, duty or liability. Exercise of any rights under this Section 3.4 and the application of the Rents to the Indebtedness or the Obligations shall not cure or waive any Event of Default.

Article 4

CC VENANTS

#### 4. Covenants

Until the entire Indebtedness shall have been paid in full, Mortgagor hereby covenants and agrees as follows:

- Compliance with Laws. Mortgagor shall promptly and faithfully comply with, conform to and obey all present and future laws, ordinances, rules, regulations and requirements of every duly constituted governmental authority or agency and of every Foard of Fire Underwriters having jurisdiction, or similar body exercising similar functions, which may be applicable to it or to the Mortgaged Property, or any part thereof, or to the use or manner of use, occupancy, possession, operation, maintenance, alteration, repair or reconstruction of the Mortgaged Property, or any part thereof, whether or not such law, ordinance, rule, order, regulation or requirement shall necessitate structural changes or improvements or interfere with the use or enjoyment of the Mortgaged Property.
- 4.2 <u>Payment of Impositions</u>. Mortgagor will duly pay and discharge, or cause to be paid and discharged, the Impositions, such Impositions or installments thereof to be paid prior to the day before any fine, penalty, interest or cost may be added thereto or imposed by law for the non-payment thereof; provided, however, that if, by law, any Imposition may be paid in installments, Mortgagor may pay the same in such installments.
- 4.3 Repair. Mortgagor will keep the Mortgaged Property in good order and condition and make all necessary or appropriate repairs, replacements and renewals thereof and will use its

best efforts to prevent any act or thing which might impair the value or usefulness of the Mortgaged Property, and Mortgagor will and Mortgagor will cause each of the other Mortgagors to obtain the written consent of Mortgagee prior to (i) making any alterations or additions to the Mortgaged Property or (ii) removing any of the Buildings or Fixtures (except as contemplated by the Loan Agreement).

Mortgagor will maintain insurance upon the Mortgaged Property 4.4 Insurance. against loss by fire and such other hazards, casualties and contingencies as are normally and usually covered by extended coverage policies in effect in the locality where the Mortgaged Property is situated and such other risks as may be specified by Mortgagee, from time to time, in amounts and with insure's exceptable to Mortgagee but not less than the lesser of (a) the amount of the Indebtedness, or (b) one hundred percent (100%) of the replacement value of the Buildings, Fixtures and Personalty. Mortgagor shall cause each insurance policy issued in connection therewith to provide (and the insurer issuing such policy to certify to Mortgagee) that (i) loss payments will be payable to Mortgagee as its interests may appear, such payments to be applied to the restoration, repair or replacement of the Mortgaged Property; provided, however, that if an Event of Default has occurred and is continuing or an event has occurred and is continuing which with the passage of time or the giving of notice would constitute an Event of Default, then such payments shall be applied to the payment of the Indebtedness; (ii) the interest of Mortgagee shall be insured regardless of any breach or viciation by Mortgagor of any warranties, declarations or conditions in such policy; (iii) if any such ins nance policy be subject to cancellation or be endorsed or sought to be endorsed to effect a change in coverage for any reason whatsoever, such insurer will promptly notify Mortgagee and such cancellation or change shall not be effective as to Mortgagee until thirty (30) days after receipt by Mortgagee of such notice; and (iv) Mortgagee may, but shall not be obligated to, make premium payments to prevent such cancellation, and that such payments shall be accepted by the insurer. For purposes of this Section, replacement value of the Buildings, Fixtures and Personalty shall be equal to the cost of replicing the Buildings, Fixtures and Personalty, exclusive of the cost of excavation, foundations and footings below the lowest basement floor and shall be determined from time to time during the terms of the Notes (but no more frequently than once in any twelve 12 calendar months) at the written request of Mortgagee by an engineer, appraiser, architect or contractor designated by Mortgagee, approved in writing by Mortgagor, and paid by Mortgagor. In addition, Mortgagor shall furnish to Mortgagee duplicate executed copies of each such policy at the time of execution hereof, and copies c1 each renewal policy not less than thirty (30) days prior to the expiration of the original policy or the preceding renewal policy (as the case may be), together with receipts or other evidence that the remiums thereon have been paid; and furnish to Mortgagee on or before fifteen (15) days after the close of each fiscal year of Mortgagor a statement of Mortgagor of the amounts of insurance maintained in compliance with this Subsection, of the risks covered by such insurance and of the insurance company or companies which carry such insurance.

#### Disbursement of Insurance or Eminent Domain Proceeds. 4.5

Before commencing to repair, restore or rebuild following damage to, or destruction of, all or a portion of the Mortgaged Property, where the damage or destruction is valued in excess of \$25,000.00, whether by fire or other casualty or by a taking under the

power of eminent domain, Mortgagor shall obtain from Mortgagee its approval of all site and building plans and specifications pertaining to such repair, restoration or rebuilding, which approval will not unreasonably be withheld.

- (b) Prior to each payment or application of any insurance proceeds or a condemnation or eminent domain award to the repair or restoration of the improvements upon the Mortgaged Property to the extent permitted herein (which payment or application may be made, at Mortgagee's option, through a construction escrow, the terms and conditions of which are satisfactory to Mortgagee and the cost of which is to be borne by Mortgagor), Mortgagee shall be entitled to be satisfied as to the following:
  - (i) An Event of Default has not occurred;
  - Either (A) such improvements have been fully restored, or (B) the expenditure of money as may be received from such insurance proceeds or condemnation award will be sufficient to repair, restore or rebuild the Mortgaged Property, free and clear of all liens, claims and encumbrances, except the lien of this Mortgage and the Permitted Exceptions, or, in the event such insurance proceeds or condemnation award shall be insufficient to repair, restore and rebuild the Mortgaged Property, Mortgagor has deposited with Mortgagee such amount of money which, together with the insurance proceeds or condemnation award, shall be sufficient to restore, repair and rebuild the Mortgaged Property; and
  - (iii) Prior to each disbursement of any such proceeds held by Mortgagee in accordance with the terms of this Pringraph 4.5 for the cost of any repair, restoration or rebuilding, Mortgagee shall be furnished with a statement of an architect selected by Mortgagee (the cost of which shall be borne by Mortgagor), certifying the extent of the repair and restoration completed to the date thereof, and that such repairs, restoration, and rebuilding have been performed to date in conformity with the plans and specifications approved by Mortgagee and with all statutes, regulations or ordinances (including building and zoning ordinances) affecting the Mortgaged Property; and Mortgagee shall be furnished with appropriate evidence of payment for labor or materials furnished to the Mortgaged Property, and total or partial lien waivers substantiating such payments.
- (c) Prior to the payment or application of insurance proceeds or a condemnation award to the repair, restoration or rebuilding of the improvements upon the Mortgaged Property to the extent permitted herein, there shall have been delivered to Mortgagee the following:
  - (i) A waiver of subrogation from any insurer with respect to Mortgagor or the then owner or other insured under the policy of insurance in question;

- Such plans and specifications, such payment and performance bonds and such insurance, in such amounts, issued by such company or companies and in such forms and substances, as are required by Mortgagee.
- In the event Mortgagor shall fail to restore, repair or rebuild the (d) improvements upon the Mortgaged Property within a time deemed satisfactory by Mortgagee, then Mortgagee, at its option, may commence and perform all necessary acts to restore, repair or rebuild the said improvements for or on behalf of Mortgagor. In the event insurance proceeds or condemnation award shall exceed the amount necessary to complete the repair, restoration or rebuilding of the improvements upon the Mortgaged Property, such excess shall be applied on account of the unpaid principal balance of the Loan irrespective of whether such balance is then due and payable, and no Prepayment fee shall be applicable thereto.
- In the event Mortgagor commences the repair or rebuilding of any (e) improvements located on the Mortgaged Property, but fails to comply with the conditions precedent to the payment or application of insurance proceeds or a condemnation or eminent domain award set forth in this Paragraph 4.5 or Mortgagor shall fail to restore, repair or rebuild the improvements upon the Mortgaged Property within a time deemed satisfactory by Mortgagee, and if Mortgagee does not restore, repair or rebuild the said improvements as provided in subpargraph (d) above, then such failure shall constitute an Event of Default.
- Performance of Leases and Other Agreements. Mortgagor will duly and punctually 4.6 perform all material covenants and agreements expressed as binding upon it under the Lease or Leases and other agreements to which it is a party with respect to the Mortgaged Property or any part thereof, and will use its best efforts to enforce or secure the performance of each and every obligation and undertaking of the respective lessees under the Lease and will appear and defend, at its cost and expense, any action or proceeding arising under or in any manner connected with the Lease or the obligations and undertakings of the lessor thereunder. Mortgagor will immediately notify Mortgagee in writing of any notice of default received by Mortgagor from the Lessee thereunder.
- Inspection. Mortgagor will permit and will cause the other Mortgagors to permit 4.7 Mortgagee, at all reasonable times, to inspect the Mortgaged Property. Mortgagee shall have the right to enter onto the Mortgaged Property, at all times, upon reasonable notice, to inspect the Mortgaged Property for the existence of Hazardous Materials on the Mortgaged Property and to determine the compliance of the Mortgaged Property and its use with any law, rule or regulation relating to industrial hygiene or environmental conditions, including soil and ground water conditions and the compliance of the Mortgagor and the Mortgaged Property with the conditions and covenants set forth herein with respect to Hazardous Materials.
- Hold Harmless. Mortgagor will employ legal counsel acceptable to the Mortgagee 4.8 and who is not also representing the Mortgagee in any other matter, and will defend and hold Mortgagee harmless from any action, proceeding or claim affecting the Mortgaged Property, or the

validity of the Notes or the other Loan Documents. Mortgagor shall appear in and defend (or pay the reasonable expenses of Mortgagee to defend, if Mortgagor elects to allow Mortgagee to handle such defense) any action or proceeding purporting to affect the security of this Mortgage and/or the rights and/or powers of Mortgagee hereunder, and Mortgagor shall pay all costs and expenses (including costs of evidence of title and reasonable attorneys' fees) in any action or proceeding (which is brought within any applicable statute of limitations) in which Mortgagee may so appear and/or any suit brought by Mortgagee to foreclose this Mortgage, to enforce any obligations secured by this Mortgage, and/or to prevent the breach hereof. Mortgagor's obligations under this Section 4.8 shall survive payment of the Indebtedness for a period of five (5) years.

- A.9 <u>Books and Records</u>. Mortgagor will maintain full and complete books of account and other records reflecting the results of its operations (in conjunction with its other operations as well as its operations of the Mortgaged Property), in accordance with generally accepted accounting principles or on a carle basis, and furnish or cause to be furnished to Mortgagee such financial data and other information, including, without limitation, copies of all Leases, as Mortgagee shall, from time to time, reasonably equest with respect to Mortgagor, Guarantor, and the ownership and operation of the Mortgaged Property, and Mortgagee shall have the right, at reasonable times and upon reasonable notice, to audit Mortgagor's books of account and records.
- 4.10 Awards. Mortgagor will file and prosecute its claim or claims for any Awards in good faith and with due diligence and cause the same to be collected and paid over to Mortgagee, and hereby irrevocably authorizes and empowers Mortgagee, if it so desires, to file such claim and collect any Awards and agrees that the proceeds of any Awards will be applied by Mortgagee in reduction of any portion of the Indebtedness as Mortgagee may determine in accordance with Article 7 hereof.
- 4.11 <u>Licenses</u>. Mortgagor shall keep in full force and effect all licenses, permits and other governmental approvals which are necessary for the operation of the Mortgaged Property and related facilities, and furnish evidence satisfactory to Mortgagee that the Mortgaged Property and the use thereof comply with all applicable zoning and building laws, regulations, ordinances and other applicable laws.
- 4.12 <u>Junior Financing</u>. Mortgagor shall not, without the prior written consent of Mortgagee, which, if no Event of Default has occurred, consent will not unreasonably the withheld, incur any additional indebtedness or create or permit to be created or to remain, any mortgage, pledge, lien, lease, encumbrance or charge on, or conditional sale or other title retention agreement, with respect to the Mortgaged Property or any part thereof or income therefrom, other than the other Loan Documents and the Permitted Encumbrances.
- 4.13 <u>Representations and Covenants of Mortgagor</u>. Mortgagor hereby represents and covenants to Mortgagee that:
  - (a) Mortgagor is qualified to do business in the State of Illinois and Mortgagor is in compliance with all laws, regulations, ordinances and orders of public authorities applicable to Mortgagor or the Mortgaged Property.

#### Article 5

#### **EVENTS OF DEFAULT**

#### 5. Events of Default

The term "Event(s) of Default", as used in the other Loan Documents and in the Notes shall mean the occurrence or happening, from time to time, of any one or more of the following:

- payment of Indebtedness. - Bankruptcy, Receivership, Insolvency, Etc. If voluntary or involuntary proceedings under the Federal Bankruptcy Code, as amended, shall be commenced by or against the any Mortgagor or Guarantor or bankruptcy, receivership, insolvency, recrganization, dissolution, liquidation or other similar proceedings shall be instituted by or against any Mortgagor or Guarantor with respect to all or any part of Mortgagor's or Guarantor's property under the Federal Bankruptcy Code, as amended, or other law of the United States or of any state or other competent jurisdiction, and if such proceedings are instituted against any such Mortgagor or Guarantor, it shall consent thereto or shall fail to cause the same to be discharged within ninety (90) days of filing.

- 5.6 <u>Destruction of Improvements</u>. If any of the Buildings other improvements are demolished or removed by Mortgagor without Mortgagee's written consent.
- 5.7 <u>Default Under Other Mortgage</u>. The right to enter and take possession of the Mortgaged Property, to manage and operate the same, and to collect the Rents, issues and profits thereof, whether by receiver or otherwise, shall be cumulative to any other right or remedy hereunder or

  - To reimburse Mortgagee for all reasonable costs and expenses, including (a) reasonable attorneys' fees incurred in connection with collecting the said proceeds;
    - (b) To the payment of accrued and unpaid interest on the Notes;

- (c) To the prepayment of the unpaid principal of the Notes, without premium; and
- (d) To the payment of the balance of the Indebtedness. The balance, if any, will be paid to Mortgagor.

#### Article 8

#### **MISCELLANEOUS**

- Earther Assurances. Mortgagor shall, upon the reasonable request of Mortgagee, execute, acknowledge and deliver such further instruments and do such further acts as may be necessary, desirable or proper to carry out more effectively the purpose of this Mortgage, to facilitate the assignment or transfer of the Notes and the other Loan Documents, and to subject to the liens of the other Loan Documents, any property intended by the terms thereof to be covered thereby, and any renewals, additions, substitutions, replacements or betterments thereto. Upon any failure by Mortgagor to execute and deliver such instruments, certificates and other documents on or before ten (10) days after a written request therefor is given to Mortgagor, Mortgagee may make, execute and record any and all such instruments, certificates and Mortgagor irrevocably appoints Mortgagee the agent and attorney-in-fact of Mortgagor to do so.
- 8.2 <u>Recording and Filing</u>. Mortgagor, at its expense, will cause the other Loan Documents, all supplements thereto and any financing statements at all times to be recorded and filed and re-recorded and re-filed in such manner and in such places as Mortgagee shall reasonably request, and will pay all such recording, filing, re-recording and re-filing taxes, fees and other charges.
- 8.3 <u>Notice</u>. All notices, demands, requests and other communications required under the other Loan Documents and the Notes shall be in writing and shall be deemed to have been properly given if sent by U. S. certified or registered mail, postage prepaid, or personal delivery, addressed to the parties and at the addresses and effective at the times set forth in Paragraph 11.6 of the Loan Agreement.
- 8.4 Mortgagee's Right to Perform the Obligations. If Mortgagor shall fail to trake any payment or materially perform any act required by this Mortgage or the other Loan Documents, then, at any time thereafter, upon reasonable prior notice to or demand upon Mortgagor and without waiving or releasing any obligation or default, Mortgagee may make such payment or perform such act for the account of and at the expense of Mortgagor, and shall have the right to enter the Mortgaged Property for such purpose and to take all such action thereon and with respect to the Mortgaged Property as may be necessary or appropriate for such purpose. All sums so paid by Mortgagee, and all reasonable costs and expenses, including, without limitation, reasonable attorneys' fees and expenses so incurred together with interest thereon at the Defaulted Interest Rate, from the date of payment or incurring, shall constitute additions to the Indebtedness secured by the other Loan Documents, and shall be paid by Mortgagor to Mortgagee, on demand. If

Mortgagee shall elect to pay any Imposition, Mortgagee may do so in reliance on any bill, statement or assessment procured from the appropriate public office, without inquiring into the accuracy thereof or into the validity of such Imposition.
