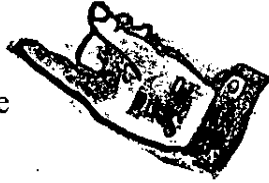

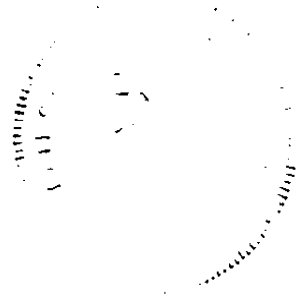

ADDENDUM "A"

Property Address: 6539 Oak Forest Ave, Tinley Park, IL.
a/k/a S.E. Corner of Vogt & Oak Forest Avenue

Legal Description:

All that part of the East 1/2 of the Southeast 1/4 of Section 30, Township 36 North, Range 13, East of the Third Principal Meridian, (excepting from said tract the South 75 feet thereof lying West of the East 160 feet thereof, as measured along the South line of said tract; and also excepting from said tract the East 160 feet measured along the South line of said tract) described as follows: to wit: beginning on a line drawn parallel and 60 feet distance Southeasterly from the Southeasterly line of the right-of-way of the Chicago Rock Island and Pacific Railway Company at a point on said line which is 108.35 feet Southwesterly from the East line of the West 1/2 of the East 1/2 of said Southeast 1/4 as measured along said parallel line and running thence South along the West line of Lot 17 in Vogt's Tinley Park Acre Lot, being a subdivision of part of the East 70 acres of the Southeast 1/4 of said Section 30, 349 feet to a point on the North line of Vogt Street and being 95.57 feet West of the East line of said West 1/2 of the East 1/2 of the Southeast 1/4 aforesaid; thence West along the North line of Vogt Street, 344.3 feet to the East line of Short Street; thence North along the East line of Short Street, 161.8 feet to a line drawn parallel with and 60 feet distance Southeasterly from the Southeasterly line of the right-of-way of the Chicago Rock Island and Pacific Railway Company; and thence Northeasterly along said parallel line 391.03 feet to the point of beginning, in Cook County, Illinois.
