**NOTICE TO PROPERTY OWNERS
WITHIN THE OLD TOWN SANITARY
DISTRICT, WHEELING TOWNSHIP,
COOK COUNTY, ILLINOIS**

WHEREAS, the OLD TOWN SANITARY DISTRICT ("DISTRICT") is a unit of local government organized and operating under the provisions of the "Sanitary District Act of 1936" (70 ILCS 2805/0.1 to 2805/93); and

WHEREAS, the DISTRICT has constructed and maintains sanitary sewer mains within the DISTRICT'S boundaries to be used by property owners therein; and

WHEREAS, the Board of Trustees of the DISTRICT has passed and adopted various ordinances, including, but not limited to (a) requiring connection to the DISTRICT'S sanitary sewer mains, (b) prescribing construction materials and methods to be used in connecting property owner's property to the DISTRICT'S sanitary sewer mains, and (c) tap-on fees required to be paid to the DISTRICT by each property owner in order to connect to the DISTRICT'S sanitary sewer mains.

NOW, THEREFORE, please take notice that the real property legally described on EXHIBIT "A", attached hereto and made a part of this notice, is within the boundaries of the DISTRICT and is subject to all of the aforementioned DISTRICT ordinances including mandatory connection of improved real property to the DISTRICT'S sanitary sewer mains and payment of tap-on fees.

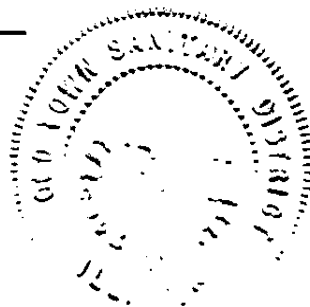
