To execute and deliver Affidavits of Debt, Substitutions of Trustee, Substitutions of Counsel, Non-Military Affidavits, Notices of Rescission, Foreclosure Leeds, Transfer Tax Affidavits, Affidavits of Merit, Verifications of Complaints, Notices to Quit, Bankruptcy Declarations for the purpose of filing motions to lift stays, and other documents of notice filing on behalf of Keystone in connection with foreclosure, bankruptcy and eviction actions;
- 3. To endorse any checks or other instruments received by Ocwen and made payable to the Keystone.


