



DISCHARGE OF MORTGAGE

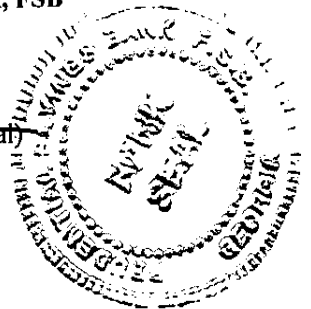

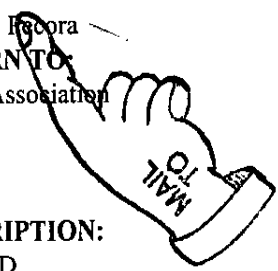
